concerned about the situation in Afghanistan. We want an inclusive government. We want that the Afghan soil should not be a source of terror for other countries in the region," Kudashev said.

"These are the very basic values that bring Russia and India together. I do not see much of a difference in our position on Afghanistan," he said.

Asked about Pakistan backing various terror groups operating in Afghanistan and whether they pose a threat to

regional security, Kudashev said Russia expects Pakistan to be among the countries that would like to see predictability and a secure environment in Afghanistan.

Kudashev said tackling the threat of terror has been a matter of continued dialogue between Russia and India under multiple frameworks. "Counter-terrorism is part of each and every bilateral meeting. Rest assured we know about this danger and we are most willing to cooperate to deal with it," he said.
