

ter Arvind Kejriwal on Tuesday opposed the Goods and Services Tax (GST) and said the system of uniform tax is not right for a country like India and he is personally not in favour of it.

The AAP convener claimed the GST is "highly complicated" and called for need to simplify it so that traders and industrialists can pay taxes easily. He said a few days back, the Centre imposed GST on (pre-packed and labelled items like curd, buttermilk, wheat and rice and wondered they will now impose GST on air as well.

Addressing a gathering of traders and industrialists in the city of Gujarat, the Assembly polls later this year, Kejriwal made five promises if he is voted to power, including removal of the environmental fear and simplification of the GST administration at the state level. He said, "From various Micro, Small and Medium Enterprises (MSME) sectors joined.

the town hall meet organised by the AAP, with representatives raising the issues of complicated GST and unnecessary and unexpected hike in the GST by the Centre.

Kejriwal said, "GST is so complicated that a large number of small traders whom I know had to shut down their businesses as they were not able to fulfil the GST requirements. The uniform tax — same tax on same kind of things — is also not right. In our country, the economy of Gujarat and other states is different. Taxes can be different on the same thing in different states and a same thing may require tax there and not here. I am personally not in favour of the system."

This entire complicated system needs to be simplified so that traders and industrialists can pay tax easily, he said. Even before a tax system, there is a need to improve the economy so that businesses can run and employment is generated.

Biswa Sarma, who is also the convener of North East Democratic Alliance, was present in the meeting. Rio said, "Negotiations are going on. It depends on the negotiating parties...We are hopeful." The Union government had signed a framework agreement with the major Naga group National Socialist Council of Nagaland (IM) on August 3, 2015. PTI

HC asks BMC not to take action on Narayan Rane's bungalow

EXPRESS NEWS SERVICE MUMBAI, JULY 26

THE BOMBAY High Court on Monday directed the Brihanmumbai Municipal Corporation (BMC) not to take action against an eight-storey bungalow in Juhu that is owned by Union minister and BJP leader Narayan Rane till further orders.

The court also directed Rane to not carry out any further construction at the plot till the next date of hearing, August 23.

A bench of Justices Ramesh D Dhanuka and Kamal R Khata passed the order while hearing a petition filed by Rane-owned Kaalkaa Real Estates seeking di-

rections to the corporation to decide on its second application for regularising the alleged unauthorised structures at the bungalow. The application was filed in accordance with various provisions of the Development Control and Promotion Regulations (DCPR)-2034. However, the company was informed that as per June 23 order of the high court, the corporation required a direction from the court to consider the application for regularisation.

Last month, the court dismissed Kaalkaa Real Estates' petition challenging the corporation's refusal to regularise the Juhu bungalow. But the court extended protection from "coercive action" for the bungalow by six weeks,

thus enabling his company to challenge the order in the Supreme Court.

The corporation issued a notice to Kaalkaa Real Estates in March directing it to remove alleged unauthorised construction on the premises within 15 days, failing which it would demolish those portions and recover the charges from the owners or occupants. The notice was challenged before the high court, which directed the corporation not to proceed with any coercive action till it decided on the regularisation application.

The corporation on June 3 rejected the application, a decision that was questioned in the court, which rejected the company's

plea on June 23.

The court was on July 19 informed that Kaalkaa Real Estates' architect filed a new application as per DCPR-2034 on July 11, considering the plot's floor space index, as was factored while granting permission to get an occupation certificate. The firm said it was not part of the earlier application for regularisation.

Kaalkaa Real Estates, through advocate Shardul Singh, said it was informed by the corporation that due to the June 23 high court order, it could not consider a new application without a court order. The company, however, said that there was no prohibition in law on filing a fresh application for building permission.

CBI TAKES OVER DATA LEAK PROBE

Union Home Secretary seeks to withdraw appeal against court order

SADAF MODAK MUMBAI, JULY 26

DAYS AFTER the newly formed state government transferred a case to the CBI concerning leak of sensitive call recordings from the State Intelligence Department (SID), the Union government approached a special court on Monday seeking to withdraw its appeal against a court order, which had directed the Union Home Secretary to give access of documents to investigators.

The Maharashtra government had last week issued orders to transfer two cases to the CBI. One of the cases pertained to an FIR registered in March last year under the Official Secrets Act by the Mumbai police against unknown persons. The FIR was registered after then leader of Opposition Devendra Fadnavis alleged lobbying by IPS officers with politicians of the then Maha Vikas Aghadi (MVA) government for postings in exchange of money. Fadnavis had then said in a press interview that he had handed over documents linked to the case to the Union Home Secretary. The previous state government had then approached a Magistrate's Court seeking directions to the Home Secretary to share the documents with the investigators of the case. The court had in December allowed the previous government's plea stat-

ing that the Home Secretary was in possession of the documents and a pen drive handed over by Fadnavis, and directed for those to be handed over to the investigators. The Home Secretary then approached the special court with an appeal stating that the application seeking documents filed by the government was vague and did not establish nature of the documents sought. Since January, the matter has been coming up for hearing but was not decided yet.

On Monday, lawyer Shreeram Shirsat representing the Union secretary informed the court that the case has been transferred to the CBI and sought for the appeal to be disposed of. The court posted the case for hearing on Tuesday. Following the change in power in the state, besides two cases, including a probe against BJP leader Girish Mahajan, being transferred to the CBI, the appointments of special public prosecutors in some cases have also been changed.

GANGRAPE CASE: FORMER UP MLA'S SON HELD FROM PUNE

Pune: The son of a former MLA from Uttar Pradesh, who was wanted for years in connection with a gang-rape case, was arrested from Hadapsar area of Pune city on Sunday night. Police have identified the accused as Vishnu Mishra (34), son of Vijay Mishra, a four-time former MLA. A Varanasi-based singer had lodged a complaint of gang-rape against three persons, including Vijay Mishra and his son. Vishnu has been on the run since August 2020, said police. A look-out circular was issued against him in September of the year. ENS

Almost a month since CM, deputy CM took oath, Maharashtra yet to get a cabinet

IT HAS been 25 days since Maharashtra Chief Minister Eknath Shinde and Deputy Chief Minister Devendra Fadnavis took oath. The two made four trips to Delhi since then to talk to the BJP top brass about expanding the Council of Ministers. But, given the high number of aspirants from both the rebel Shiv Sena leaders' camp and the BJP side, the exercise has been on hold.

The Cabinet expansion, however, is expected to take place this week as the state Assembly's Monsoon session is likely to be held in the first week of August and the Opposition is using the current situation to accuse the Maharashtra government of hampering relief operations in areas of the state which affected by incessant rains.

It remains to be seen how the BJP and Shinde accommodate the high number of aspirants in the Council of Ministers that can have a maximum of 43 ministers, including the CM.

In the rebel Shiv Sena camp, excluding Shinde, there are eight former ministers - four Cabinet ministers and four ministers of state (MoS) - from the previous Uddhav Thackeray-led administration. According to insiders in the Shinde camp, former MoS and Independent MLA Bachchu Kadu has been promised a Cabinet berth.

The Shinde camp also has bigwigs such as Tanaji Sawant from Osmanabad district and Deepak Kesarkar from Sindhurg. Both of them were ministers in the BJP-Shiv Sena government that was in power from 2014 to 2019.

The incumbent CM also has to contend with the aspirations of Sanjay Rathod, the forest minister in the Uddhav Thackeray government who had to resign over a case of a woman's suicide. Shinde may

also have to accommodate his key aide and the Sena rebels' Assembly chief whip Bharat Gogawale from Mahad in Raigad district. In addition, Sanjay Shirsat from Aurangabad district is also looking to bag a ministerial position.

The BJP leadership too has to accommodate several top leaders, including senior MLAs and ministers in the previous BJP-led government in the state. According to party insiders, several such leaders have been camping in Delhi to lobby for a Cabinet berth and important portfolios.

While uncertainty remains over whether Fadnavis will get the home or finance portfolio, BJP functionaries said senior leaders and former ministers such as state BJP chief Chandrakant Patil, Sudhir Mungantiwar, Ashish Shelar, Sanjay Kute, and Pravin Darekar were expected to get charge of important ministries.

But, sensing the uncertainty among his party colleagues, Fadnavis on Saturday advised them during a BJP executive committee meeting

that they should exercise restraint and even hinted that all hopefuls might not get accommodated in the Cabinet expansion.

"The Cabinet expansion will take place two to three days prior to the Monsoon session of the legislature, which could be held in the first week of August," said a senior BJP leader.

ECI to launch campaign in state to link Voter ID with Aadhaar from August 1

EXPRESS NEWS SERVICE MUMBAI, JULY 26

THE ELECTION Commission of India (ECI) will start a campaign across Maharashtra to link Voter ID cards with Aadhaar from August 1. The aim of this voluntary drive is to establish the identity of electors and authenticate entries in the electoral roll as well as to identify if the same person is registered in the electoral roll as well as to identify if the same person is registered in more than one constituency or more than once in the same constituency.

"To link Aadhaar card to Voter ID card, voters need to fill application form 6-B available online on the election commission website and at electoral registration offices. It can be linked online on Voter helpline app and national voter service portal, too," said Shrikant Deshpande, Chief Election Officer (CEO) of Maharashtra.

He said linking the Aadhaar number with Voter ID is voluntary. "No existing voter's name will be omitted from the electoral list on the ground that the Aadhaar number has not been submitted," he said, adding that there is provision for a double lock system for the security of voters' physical documents and computerised information. He said masking will be used to keep the Aadhaar card number confidential.

According to the ECI, linking Voter ID and Aadhaar establishes the identity of elector and authenticates entries in electoral rolls, avoids duplication of voter names and informs voters about the latest notifications from the election commission through mobile phones.
