
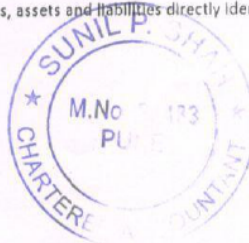



The above financial results have been reviewed by the Audit committee and approved by the Board of Directors of the Company at their meetings held on 10<sup>th</sup> February, 2026.



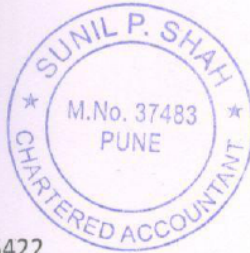
